



Multi-Currency Cash Passport™ New Zealand Chance to Win Campaign 2017 Terms and Conditions

1. The promoter is MasterCard Prepaid Management Services (NZ) Ltd ("Promoter") of Level 3, MasterCard House, 136 Customs Street West, Auckland New Zealand.
2. This campaign commences at 00:00 on 1st May 2017 and closes at 23:59 on 31 July 2017 ("Promotional Period"). The Promotional Period may be amended and extended if advised by further notice. Taking part in this campaign constitutes acceptance of these Terms and Conditions.

For every NZD \$100 equivalent loaded or reloaded, in foreign currency by an Eligible Entrant onto their Cash Passport in-store or online during the Promotion Period, the Eligible Entrant will receive one entry into a draw to win either the major prize of NZD\$10,000 to be loaded on the Prize winner's Cash Passport or one of ten runner up prizes of NZD\$1,000 to be loaded on the Prize winner's Cash Passport ("Prize").
