

Multi-currency Cash Passport™ New Zealand \$25 Bonus Campaign 2018

Multi-currency Cash Passport – Promotion Terms & Conditions

- 1. The promoter is MasterCard Prepaid Management Services (NZ) Ltd ("Promoter") of Level 3, MasterCard House, 136 Customs Street West, Auckland New Zealand.
- This campaign commences at 00:00 on 1st June 2018 and closes at 23:59 on 30 June 2018 ("Promotional Period"). The Promotional Period may be amended and extended if advised by further notice. Taking part in this campaign constitutes acceptance of these Terms and Conditions.
- 3. Entry is open to all residents of New Zealand who purchase a new Multi-currency Cash Passport ("Cash Passport") and loads in foreign currency with a minimum amount of \$1,500 (New Zealand Dollar equivalent) on first load, between 00:01 1st June 2018 and 11:59 30th June 2018 inclusive ("Promotion Period") in a single transaction at participating stores and successfully registers their Cash Passport online for this promotion, at <u>https://www.cashpassport.co.nz/bonus25</u> before 30th June 2018 ("Eligible Entrant").
- 4. Eligible Entrants must not be in breach of any terms and conditions of this campaign or of the terms and conditions of their Multi-Currency Cash Passport.
- 5. The Promoter reserves the right to review and amend these terms and conditions at any time. Decision of the Promoter is final and no further correspondence will be entered into.
- 6. The promotion will be advertised in participating stores and online at <u>www.cashpassport.co.nz</u>. Please note that participating stores who make any promotional and related material regarding this promotion available to persons (either in their stores or online) do so on the basis that all such material has been prepared by and remains the property of the Promoter. Participating stores do not run or provide any warranties in relation to the promotion and as such, shall not be liable in any way to any third party in connection with the promotion. All applicable exchange rates, ATM fees or charges may be deducted from the total amount of funds on the Cash Passport at the time the relevant transaction is made. The Cash Passport is valid for up to five (5) years but inactivity fees may apply after twelve (12) months of non-usage of the Cash Passport. The total residual fund of the Cash Passport may be withdrawn at any time and will incur a fee depending on the country of activity.
- 15. Should an Eligible Entrant's contact details change during this promotion, it is the Eligible Entrant's responsibility to immediately notify the Promoter. A request to modify any information provided in an entry should be directed to the Promoter.
- 16. If for any reason, the Promoter is unable to run this promotion as planned, including tampering, infection by computer virus, bugs, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter that corrupt or otherwise affect the administration, security, fairness, integrity or proper conduct of this promotion, the Promoter may in its sole discretion disqualify any person who tampers with the entry process, and cancel, terminate, modify or suspend this promotion without prior notice, subject however to any written directions given under applicable law.
