New Zealand ‘Load more get more’ bonus campaign September – November 2019

Cash Passport™ – Promotion Terms & Conditions of Entry (“Conditions of Entry”)

1. The promoter is Mastercard Prepaid Management Services (NZ) Limited of Level 3, Mastercard House, 136 Customs Street West, Auckland, New Zealand (the “Promoter”). The Multi-currency Cash Passport™ (“Cash Passport”) and Cash Passport™ Platinum Mastercard® (“Cash Passport Platinum”) are unsecured debt securities issued by Travelex Card Services Limited, a member of the Travelex Group. Cash Passport and Cash Passport Platinum are not guaranteed by any member of the Travelex Group or any other entity.
2. Entry is open to all residents of New Zealand who reload in foreign currency with a minimum amount of \$1,000 (New Zealand Dollar equivalent) in a single transaction on an existing Cash Passport or Cash Passport Platinum between 9:00am NZDT on 30 September 2019 and 11:59pm NZDT on 1 November 2019 inclusive (“Promotion Period”) online at www.cashpassport.co.nz and successfully register their transaction online at <https://www.cashpassport.co.nz/loadmore> before 1 November 2019 (“Eligible Entrant”). Duplicate registrations will be deleted.
3. Eligible Entrants who reload foreign currency in a single transaction in accordance with the “Reload Amount” (set out in column 1 of the table below) will be credited with the respective “Bonus Amount” (set out in column 2 of the table below) to their New Zealand Dollar currency wallet on their relevant Cash Passport (“Bonus”).

4. The maximum Bonus amount that each Eligible Entrant can receive during the Promotion Period is \$200 (NZD). The promotion will only apply to the first reload by an Eligible Entrant during the Promotion Period. All amounts will be credited to Bonus recipients within 30 days of a valid registration being received.
5. The Promotion Period may be amended and extended if advised by further notice. Taking part in this promotion constitutes acceptance of these terms and conditions.

6. Eligible Entrants must not be in breach of any terms and conditions of this promotion or of the terms and conditions of their Cash Passport or Cash Passport Platinum (as applicable).

The Cash Passport and Cash Passport Platinum are each valid for up to five (5) years but inactivity fees may apply after twelve (12) months of non-usage of the relevant Cash Passport. The total residual fund of the relevant Cash Passport may be withdrawn at any time and will incur a fee depending on the country of activity.
15. Should an Eligible Entrant's contact details change during this promotion, it is the Eligible Entrant's responsibility to immediately notify the Promoter. A request to modify any information provided in an entry should be directed to the Promoter.
